In August of 2013, the Trustees decided the parsonage needed some updating and established a Parsonage Renovation Committee to look into this effort. The committee included Larry Hinebaugh (Chairman), Teresa Barr, Phyllis Fretwell and Bruce Rogers. It developed a list of proposed changes to be made at the parsonage. Using this list, three contractors were contacted and asked to tour the parsonage, evaluate the proposed changes, prepare and submit bids on how they would make these changes and the cost to complete them. The committee prepared a comparison sheet of the three contractor bids and presented it to the Trustees for evaluation. After careful discussion and deliberation, the Trustees selected the proposal from Breeding Construction. They presented their recommendation to the Administrative Council and received the approval to proceed with the parsonage changes using a budget of \$50,000. Breeding Construction (Mike Breeding) was announced as the project contractor in March 2014. (continued on page 4)

With the preliminary work for the project completed, Kevin Armstrong and the Finance Committee began the critical task of funding for this important project. They decided to secure a credit line from the Dupont Community Credit Union (DCCU) and simultaneously begin a campaign to raise money through donations from the congregation. These proposals were presented to the Administrative Council and approved in February 2014. The Finance Committee worked with DCCU to secure the line of credit. Kevin spoke to the congregation announcing the fund drive and a funding thermometer was set up in the Narthex to track the success of this effort.

At the end of June 2014, Pastor Doug moved out of the parsonage and it was empty for the first time in many years. Teresa Barr and an outstanding group of volunteers began the process of removing wallpaper from most of the parsonage rooms. A long, tedious and dirty process, they continued until the many layers of wallpaper were removed. In some cases, the walls had to be covered with a thin layer of plaster to make them smooth but the end result was a very different look in these rooms. All of this work was done over a period of several months. In September, another group of volunteers demolished the interiors of the upstairs and downstairs bathrooms removing all the fixtures, tile, walls, floors, ceilings and everything but the wall supports. The removal filled two dump trailers of trash and debris. This too was a dirty process, but it enabled us to transform these rooms into a very different space.



In September, Mike Breeding began working in the parsonage. He started in the upstairs bathroom by removing an old chimney from above the roof down to the second floor and increasing the floor space for the bathroom. This floor space was further increased by moving a wall between the bathroom and the adjoining bedroom out 20 inches. With these two changes, the floor space for the upstairs bathroom was doubled in size. Plumbing and electrical work for both of the

bathrooms and the laundry area was completed before the drywall could be installed. After this was all completed, Mike installed the new cabinets, sinks and other fixtures in the bathrooms. The bathrooms have now been painted and look outstanding.

He has installed a french door between the dining room and den; in the kitchen he installed a new counter top and under the counter lighting; he has also repaired the hardwood floors to prepare them for refinishing.

If you have not been in the parsonage and seen many of the things mentioned above, I encourage you to do so during one of the "open houses" being conducted during this project.



Where do we go from here?

The Parsonage Renovation Committee has selected new appliances, kitchen counter tops, paint colors for the rooms and light fixtures. Mike continues his work to finish some electrical work, complete repairs to the hardwood floors and manage the process to refinish the floors, steps and handrail. We have made tremendous progress on a major project, but we are not finished.

What can you do?

- We need volunteers to paint the rooms. John Morse has done an outstanding job painting the ceilings and trim and priming the walls in all the rooms. We need people to paint the walls. If you can help with this, contact Owen Harner or Bruce Rogers and let them know you can help. They will work you into the schedule.
- Contribute to pay for this worthwhile project. As of February 15, 2015 members of the congregation have donated over \$20,700 toward the cost of renovating the parsonage. If you have already contributed, thank you. If you can give more or you have not yet given, we still need funds to complete the renovations and pay off the balance of the credit line. There are envelopes in the pews and the Narthex designated for this project or you can give a check to the church and mark it for the Parsonage Renovation. Every little bit will help toward completing the goal of improving our parsonage and paying off the cost.

## Nurse's Health Corner: Advanced Directives

All hospitals are required to tell patients their rights under state specific laws to make decisions about their medical care at the time they are admitted to the hospital as inpatient, according to the Patient Self-Determination Act passed by Congress in 1990. These rights include the right to accept or refuse medical or surgical treatment and the right to make advanced directives. Making decisions about end of life treatment and wishes, which can come at any age as a result of chronic disease, an accident or unexpected illness, can be very stressful and confusing.

An Advanced Directive, also called a living will, is a legal document made by you in which you state your choices about medical treatment or name someone to make decisions about your medical care if you become unable to make these decisions for yourself. Three basic parts of an advanced directive, which you may include, are appointing an agent, life prolonging treatment or procedures and making an anatomical gift following your death.

- You may appoint an agent (also known as a health care proxy) to make health care decisions for you if you are unable to make them for yourself. You can include instruction about specific treatment you want to accept or refuse. Appointing an agent to make health care decisions for you is a part of an advanced directive which is optional. If you do not choose to appoint an agent, you cross through this option in the form for an advanced directive.
- You can specify the kind of life prolonging medical care, if any, that you want provided, withdrawn or withheld if you become terminally ill and are unable to make your own decisions. Life prolonging treatment or procedures could keep you alive when your own body can no longer do that work and there is no reasonable hope that you will recover. Using them would take longer for you to die, but not make you better. Your "Living Will" tells your physician to provide, withdraw or withhold these treatment or procedure when you have a terminal condition. Life prolonging measures do not include pain medication or other care that gives you comfort. These would be provided to you.
- You may also appoint someone to make an anatomical gift or organ, tissue or eye donation on your behalf following your death.

A written advanced directive must be signed, dated and witnessed. You should share a copy with your family as well as your physician, so copies can be placed in your doctor's office and hospital electronic medical record. An advanced directive can be revoked at any time by rewriting, physical cancellation or destruction of the form by you, or someone in your presence and at your direction, or by oral expression of your intent to revoke. This is effective when communicated to your attending physician.

If a person does not have an advanced directive and they are unable to make an informed decision about medical treatment, the physician may continue to provide, withhold or withdraw treatment if he talks with one or more persons in this order: a court appointed guardian, spouse (except where a divorce action has been filed, but not final) adult children, a parent, an adult brother or sister, nearest relative, or adult that has exhibited special care and concern for the patient – per hospital review.
